

MOST HONORED COMPANIES

2016 ALL-AMERICA EXECUTIVE TEAM

A total of 1,930 companies in the United States received votes in this year's All-America Executive Team survey. Of those companies, 273 received a first-, second-, or third-place ranking in one or more of the following categories: Best CEO, CFO, IR Professional and IR Program. One hundred and forty-four companies were distinguished as "Most Honored" for receiving a total of three or more ranked positions in two or more categories, while also achieving a weighted score of at least six points based on three points for each first-place position, two for each second, and one for each third.

The following "Most Honored" companies ranked at the top of the All-America Executive Team for their corporate leadership and investor relations expertise.
